Differentiators

All employees are automatically covered. In addition, you have the possibility to insure the following persons: directors, major shareholders, trainees, volunteers, temporary workers and freelancers. It is also possible to cover (among others) visitors to museums or members of associations.



Retraining

If your employee is no longer able to fulfill his/her current position due to an accident, retraining can be the solution for a new suitable employment. These retraining costs are compensated by us.



Recruitment costs

It might be possible that your employee is no longer able to work after an accident. If you have to recruit a new employee for this reason, recruitment costs are reimbursed.



Home adaptation

- Accidents resulting from brawls, except in the case of legitimate defence.
- Accidents resulting from suicide or attempted suicide.
- Accidents occurring during bets and wagers.
